EDUCATION HIGHLIGHTS

- Teachers spent time this week talking about how our writing instruction is helping get kids ready for state testing. We looked at Work Sample data and how we can teach different skills at different times of year. A recent training attended by two teachers supported the idea that the first step is to get kids engaged in the creative process as a way to help them enjoy the writing experience. Later in the year, we will focus more on organization and conventions.
- Teachers looked at how A's, B's, and C's are distributed in their classes. For some teachers, most kids get B's but some get A's and C's. Other teachers had far more A's than others. We discussed the purpose of grades as a way to communicate with parents across grades, so consistency would be the most helpful way to go.

COMMUNITY HIGHLIGHTS

- Read Across America Day is March 2nd. This year, besides the usual guest readers and dressing up, we will have a 30 minute, school wide silent reading time to start our day. Classes will also be planning extra activities throughout the week.
- Family Movie Night is January 24th. Our student leaders will be hosting the event. They will be picking the movie and serving popcorn to the community.


