**4.1 Superintendent’s Report:** Superintendent, Gary Tempel’s packet included current enrollment numbers for 2018-19 school year. Enrollment is at 701. Mr. Tempel gave an update on the playground and gym.

### **4.2 School Reports**

**4.2.1. Centennial Elementary School:** Enrollment is up again to 319.

## EDUCATION HIGHLIGHTS

- Our efforts at improving attendance this year have been paying off. Total absences for the month of January were down more than 250 days compared to last year. With an increased enrollment of 20 students, we have 10 fewer who are considered chronically absent as of February 2/12/19. Overall, that's a 23% improvement from last year.
- Third graders are starting swim lessons in Stayton again this year. They spend two weeks traveling to the YMCA pool for leveled swimming. Kids get excited to be part of it each year, and we hope it will save lives as kids spend their summers in the streams and rivers of our area.

## COMMUNITY HIGHLIGHTS

- Read Across America Day is March 2nd. This year, besides the usual guest readers and dressing up, we will have a 30 minute, school wide silent reading time to start our day. Classes will also be planning extra activities throughout the week.
- Family Movie Night was a fun event. Our student leaders did a great job hosting the event and serving popcorn to raise funds for future activities. Their focus so far has been on improving school culture and community. They plan to have another movie before the end of the year.

### 4.2.2. Scio Middle School:

#### Athletic Update

- **Boys' Basketball:** The season concludes with a game on 2/21/19 at home against East Linn Christian.
- **Spring Sports:** Spring sports practice begins March 4, 2019. We currently have over 85 students signed up to participate in track & field, baseball, and softball.

#### Education Update

- **Staff Development:**
  - For the upcoming in-service day, the middle school staff participated in a SIOP (sheltered instruction) training at Scio Middle School.

- **School Activities/Fundraisers:**

- The next Gold Card trip is planned for 2/22/19. 56% of our school is eligible to participate. This is up from 45% last year at this time and 38% two years ago.
- The annual 7<sup>th</sup> grade field trip to OMSI has been scheduled for April 18, 2019.
- 29% of our school made the Honor Roll, which means they had a GPA of 3.5 or better for the 2<sup>nd</sup> quarter.

##### **Athletic Update:**

- Spring Coaches are up for rehire and the High School would like to rehire Jim Mask (Head Softball), Amber Seifried (Asst. Softball), John Cyrus (Head Baseball), Jeff Trissel (Asst. Baseball), and Justin Guest (Asst. Track Coach) .
- We would like to recommend Lori Ramsay as our new Volleyball coach and Jason Jacobson as our new Cross Country coach.
- Boys basketball made the playoffs.

##### **Education Update:**

- Just wrapped up the January attendance challenge and we saw an increase of students attending. See attached report.
- Looking at the Wellness survey data from last year
  - 3 things that felt positive:
    - Students realize there are many ways to get involved in activities (pg. 3)
    - Students feel school is safe compared to Linn Co. and Oregon (pg 4)
    - Most students agree that parents would think it is wrong to have one or two alcoholic drinks. (pg14)
  - 3 things that concern me:
    - Only 31% of students feel vape pens do harm (pg 16)
    - Our current freshman class has High level of ACES as well as depression & suicidal thoughts (pgs. 8-10)
    - Increase for our seniors with drugs and alcohol (pgs 12-13)
