EDUCATION HIGHLIGHTS

- State testing is underway. With more chromebooks available this year, testing is taking place at more strategic times of day around the school. That allows teachers to continue to lower any stress kids might feel during testing, and it keeps them in the place they're most accustomed to working.
- Scott Golden and Luke Zedwick will be completing the three-day training this week in the Collaborative Problem Solving method and mentality, that was introduced to our district this year. The research-based system focuses on the few kids who take up the most time with outbursts and misbehavior. So far, staff are actively using what they've learned, and it will be good to develop a base of further expertise around the district.

COMMUNITY HIGHLIGHTS

- Student leadership is hosting another movie night tomorrow night. This time they surveyed the student body about what movie they want to see, and the clear favorite was the recent Spiderman cartoon. Leaders will once again be making popcorn for sale that will go toward improving our end of year Awesome Party
- Kindergarten orientation is coming up at the end of the month. Our kinder teachers plan to begin next year the same way we started this one: with two weeks of half days rather than the older method of delaying start for a week. We also have invited our preschools to come train with our staff in August on the 7 Habits of Happy Kids materials
