4) ITEMS FOR THE INFORMATION OF THE BOARD

- **4.1 Superintendent's Report:** Superintendent, Gary Tempel's packet included enrollment numbers for 2019-20 school year. Enrollment is at 716. Asbestos Abatement inside the High School is done, they have almost completed all fo the demolition inside the gym.
- **4.2 Assistant Superintendent's Report:** Asst. Superintendent, Steve Martinelli's packet included the following:

End of Year Highlights

- High School Graduation was a success due to the work of many staff, parents and community members.
- The Senior banners are a huge source of school and community pride. Many thanks go out to everyone that made it possible for these to decorate our downtown area.
- Distance learning at Scio has been well above the standard. However, we understand this is not the educational model we want to live with for an extended period of time.
- o The Centennial slideshow brought a tear to many eyes and reminded us of everything that has been done during the past 3 months or so.
- o The 8th grade recognition has been planned and I'm sure it will be a great way to honor our middle schoolers moving on to become Loggers next year.

20 - 21 School Year

- The Oregon Department of Education will be providing draft guidance for reopening school next Fall in early June.
- o We will be engaged in the development of several plans to address the many scenarios that may present themselves. Initial indications are we will need to present a final plan at some point to the Board for approval moving forward.

- We anticipate some form of in person instruction and will move forward planning for such knowing student and staff safety will be the priority. The final model will depend on many factors.
- O We will be closely monitoring school funding and the anticipated reduction in the Student Investment Account allocations. We have a submitted SIA application and anticipate some feedback on our approval status by the end of the month. We were able to prioritize our activities based on community, staff and student feedback and will fund as many activities as we are able. We are able to adjust our plan at the end of year one and will have a better idea of the funding levels moving forward into years two and three.

4.3. School Reports

4.3.1. Centennial Elementary School

Education Highlights

- A virtual field day was held on June 10th where students were able to do fun activities at home and post pictures of the fun to google classroom.
- School t-shirts, end of the year awards, and yearbook delivery further celebrated the end of another great school year.
- A digital yearbook was shared with all of our students that highlighted our time at school and included pictures of students at home during virtual learning.
- Transition meetings via Meets or Zoom for each grade level helped students to get to know the next year's teachers.
- It became more important to keep students engaged as the year came to a close. In response teachers and learning buddies created fun digital end of the year projects, continued to motivate students through incentives, and recognized students for the great work they were doing in class meetings.
- Many teachers have prepared digital summer learning opportunities for students and are keeping Google Classroom open. Parents and students have enjoyed the new digital resources and are looking forward to continuing to support their children over the summer.

Community Highlights

- Teachers and students enjoyed watching high school graduation online.
- Scio Library sent home summer reading program information to encourage literacy.
- Centennial will continue to make meals for students this summer, starting June 15th. The meals will be available for pick up between 9am and 11am each weekday.

4.3.2. Scio Middle School

Here is what is happening at the end of the school year at Scio Middle School.

*Families are scheduled to return school resources (Chromebooks, library books, instruments, and text books) on Thursday June 11. Students will also sign up for Fall sports, receive their year book, and receive a pair of cookies.

*Promotion will take place from 7-8 pm on June 11. This is an open-house drive-through event with the families driving through the middle school teachers. The students will receive their certificate, any awards they won, and a swag bag. The parents have organized a parade prior to promotion and an ice-cream social afterward.

*Teachers will call every student to check-in to find out concerns and if they are set up for online supplemental learning.

*Teachers will make contact with each student twice weekly.

*Teachers are using Google Classroom, Google Meets, videotaped lessons, email, phone calls, Google Hangouts, paper packets, etc. to share lessons and connect with students.

*We will continue to have staff meetings every other week.

*We have special education meetings weekly.

*Principal is publishing a monthly newsletter.

*Oregon Department of Education has postponed statewide SBAC testing in ELA, math, and science.

4.3.3. Scio High School

With the Continuation of Distance Learning OnLine directive we are ending the year differently. Below you find how SHS is ending the 2019-2020 School year.

- 24 out of our 54 Seniors continued on after Graduation to continue with college coursework. Students earned Eng 104, GS 103 (physics), BI 103 (Anatomy & Physiology), and Ag sciences in Crops and soils and animal science.
- We have received nothing but good feedback from our drive-in graduation. The only technical issues were in our parking lot. Those not in our parking lot watched the whole live stream. Mr. Anundson is working on edits and putting together a final recording for each grad.
- We love our community! SHS wants to thank the City of Scio, SMTA, and those that donated money for the banners for our seniors. They look fantastic!

- 9th 11th graders will receive a Pass or Incomplete. Students can continue to work on coursework over the summer that will be graded when teachers return in August.
- Students are keeping Chromebooks over the summer to continue work.
- We had three students complete Fire Cadet 1 our new class with our collaboration with the Fire Station. These students are working on taking the State certification and will officially be EMR's (Emergency Medical Responders). They are continuing work and volunteering in a Fire Cadet Club over the summer. We have 5 new cadets for a total of 8 next year.
- We graduated 8 National Honor Society Students and will be inducting 14 students. We have set a date of October 14, 2020 to host the induction ceremony.
- We are anxious about how we will start the 2020-2021 school year. We all really miss the students.
