# 3.7 Middle School Baseball/Softball Dugouts:

Mr. Nolan presented this proposal to the Board based on 2 objectives. First one being safety and the second one being that we have great facilities and this would help. Having great facilities is our first impression. Upgrades would be the following:

Putting dugouts on both fields

- Move baseball field 25-30 feet to the east
- Proposed balling cage 20x60 feet
- Additional 30 feet of fencing for safety

Mr. Tempel let the board know that is project would be done in pieces. We would start with the Girls dugouts and then the boy's dugouts. When we move the boy's backstop the monkey bars will have to go. If we cover the tennis court there would be an outside practice place. We would remove both goal posts. We would also put scoreboards up for both softball and baseball fields. This is Mr. Tempel recommendation.

No action is required at this time. This is information for the Board for a future board meeting.

Kerri Hyde asked if we ever fixed the drinking fountain at the tennis courts. Kerri Hyde would like the drinking fountain to be fixed.

# 3.8 Middle School Handbook changes:

Mr. Nolan presented to the Board changes to the Middle School handbook. The only change is dates for the new school year. Nicole Buganski asked that all 3 schools be consistent between them with their handbooks. The dress code isn't consistent with the other 2 schools. Nicole asked about the 2 sections on medications. Kerri Hyde asked about the inhalers, as they should be with the student and not at the office. Mr. Nolan told the Board that at the Middle School the students can have their inhalers with them if their parent filled out a form and the student makes an appointment with Mr. Nolan. Mr. DeWilde also brought up that on page 17, "While riding a school bus, students will" is a smaller font and you might want to make it the same size as the rest.

Mr. Martinelli ask for approval of the Middle School handbook with changes made so Mr. Nolan can get the handbook to the printer.

# **4.1 Superintendent's Report:** Superintendent, Steve Martinelli's packet included:

Before Mr. Martinelli presents his report to the board he wanted to let the board know of an email he just received from Jim Mask, AD at the High School from the Head Baseball Coach, Keith Wallen at Brookings Harbor. Scio lost 2-1 and Scio's

pitcher Blake Brown threw a great game against Brookings Harbor. Below is the email:

Mr. Mask,

I wanted to reach out to tell you how impressed with your baseball program we were. Not only did we experience hard working, great attitude young men, but also witnessed fans applauding us after a hard fought, great baseball game! One thing in particular that stood out, was after the game was over and no one was left in the entire ballpark except our coaching staff, Blake Brown took it upon himself to walk into our dugout (after getting beat mind you) and compliment us on a great game, compliment our players, and congratulate us.... This is one of the most impressive, and joyous moments I have ever experienced in 19 years coaching youth sports. This type of leadership and mindset is exactly what we all should strive to teach these young men. That attitude and demeanor should be cherished and rewarded within not only the baseball program, but the entire community of Scio. Something truly worth being proud of!

#### **CURRENT**

- For the 2021-22 school year Scio School District is planning:
  - A return to a full day on-site schedule for students 5 days a week with a regular year school calendar
  - We will continue to follow all recommendations required of us to keep staff and students safe
  - We understand that there will still be families who are reluctant to return to on-site instruction due to specific circumstances. We do not plan to offer a Comprehensive Distance Learning option in the fall unless we are directed by the State to continue to offer it as an option.
  - There may be special circumstances where portions of time, parts of a day, during extended sickness, during required quarantines, etc that a partial online option might be available. However if a family is interested in a full time online CDL option they should look for alternative solutions.
  - ODE is currently working on guidance for the 2021-22 school year, a draft is currently being written with discussion to follow May 24 - June 11. The final published plan is to be completed by July 19, 2021 with training/Q & A's on the plan beginning August 2, 2021. The plan is likely to still include to some degree:
    - Face Coverings
    - Physical Distancing
    - COVID Testing
  - With the new announcement from the Governor's office last week regarding vaccination rates and county risk levels, I would assume we would see

something similar in regards to restrictions in the schools. Although our District has no intention of requiring a vaccine, we do believe when our region reaches a certain percentage of vaccinated individuals, more restrictions will be lifted in the schools as well. One of our primary goals is to reduce the number of significant disruptions in our school system for our students. We believe quarantines of individuals exposed to a positive case of COVID-19 will still be a component required of us to enforce next school year. If staff members or students that are available to receive the vaccine have been vaccinated, it will eliminate their requirement to quarantine.

### **4.2 GT Report**: Director of Charter Schools, Gary Tempel packet included:

Current Enrollment – 646 Willamette Connections – 1867 Lourdes – 40

Facilities: The permit request is in for the Middle School Seismic. We have signed the bids for insulation and sheetrock for the ES Kitchen addition.

Projects: We are working on getting bids for the other summer projects.

#### 4.3 School Reports

### 4.3.1 Centennial Elementary School Enrollment – 281

#### COMMUNITY / EDUCATION HIGHLIGHTS

- Our K-12 students are currently attending school from 7:50am-12:00pm. We have 257 students on campus and 23 students have chosen to remain virtual. Our teachers are continuing to use technology so that students at home can interact with those onsite.
- We have been able to increase recess, PE and music time for students now that the school day has been lengthened. These activities along with movement breaks have helped students adapt to four hours of intensified instruction. Time is dedicated to physical activity each day, along with additional movement breaks.
- Kindergarten Zoom Orientations and the delivery of welcome learning backpacks will be delivered soon. This will be coordinated with our virtual Little Hawks Preschool Program. That program currently serves 28 students and has been funded through our KPI grant (Kindergarten Partnership Innovation Grant).
- State testing will be finished by the end of May. Third grade students will take a shortened form of the language arts assessment, fourth grade will take a shortened form of the math assessment, and fifth grade students will take science.
- Mrs. Brockamp is currently working on a virtual yearbook and a virtual talent show for our students.
- Our school yearbooks in paper-bound will be ready soon.

 We are planning kindergarten graduation and a fifth grade celebration for our students during the last week of school.

#### **PROFESSIONAL DEVELOPMENT**

• Our Staff is participating in a "Design your own change" project with a grant through the Western Regional Educator Our change has been given \$15,000 of support this year and another \$15,000 to support the project through next school year. Currently we are using funds from this grant to train our instructional assistants in RULER and to support staff development opportunities.

### 4.3.2 Scio Middle School Enrollment – 149

### **Athletic Update**

- Baseball: The season ended on May 17 with a game at East Linn.
- Softball: The season ended on May 13 with a game at Perrydale.
- Track & Field: The season ended on May 3 with a track meet at Jefferson. Due to Covid-19 restrictions, the district track meet was canceled this year.

#### **Education Update**

 Hybrid instruction is underway. Here is the plan we implemented here at Scio Middle School.

\*Students are taking four classes at a time. They recently completed the 5<sup>th</sup> six-weeks rotation and have one to go.

\*Teachers are utilizing Google Classroom, Google Meets, videotaped lessons, email, phone calls, and Google Hangouts in addition to in-person provide lessons and connect with students.

\*All students are attending classes from 9:35 AM to 1:35 PM. This will include CDL instruction. This will allow each student to have the opportunity to attend 20 hours of inperson instruction per week.

\*Students that chose to continue CDL, which is the on-line learning, will be able to, because teachers are teaching simultaneously to students in CDL and in-person.

\*Students will continue rotating some classes each 6 weeks, such as PE, social studies, science, music, health, agriculture, typing, art, etc., but will have math and language arts every six weeks. At semester, many students rotated classes to add variety to their instruction.

#### **Building Update**

- SBAC/Extended Assessment: The State of Oregon has issued the plan for testing for grades 6-8. Students will test, but will complete a reduced number of tests.
- Virtual Outdoor School: Our 6<sup>th</sup> grade students completed a week of virtual outdoor school.

### 4.3.3 Scio High School Enrollment – 218

### **CDL Update:**

We currently have 23 students on CDL.

#### Hybrid:

- Just wrapped up Spring Trimester A and currently in the last 6 weeks of school (Spring Trimester B).
- We have 49 graduates this year.
- Drama finished with 1-3 act recorded plays this year. Rumpunzel (a fairytale mixup), a 3 person act, won the Anundson award.
- All students in clothing 1 were able to complete a quilt, pajama bottoms, as well as a
  zipper bag. Some students even got a second quilt and pajama bottoms completed.
  It was amazing to see how diligent the students were and the quality of their work.
- Several teachers here at the high school took on cadet teachers and had students teaching younger students. We had a junior teaching Spanish 1 following Mrs. Rounsavell's guidance. It was awesome to see him in action. Mr. G/H has students from Calculus teaching lessons to college algebra students. Mrs. Broadbent had a student working with clothing 1 giving instructions on quilt making. This student is also taking on learning the new embroidery machine. Ms. White would tell you small engines and woodshop have been as successful as they have been because of her Forestry mentors.

#### **Athletics:**

- We would like to hire; Justin Guest Assistant Track Coach, Kaitlyn Brockamp -Assistant Track Coach, McKenzie Reger - Assistant Girls Basketball Coach, and Justin Dodge - JV boys Basketball Coach
- Track had districts May 12th & 13th. Then a Culminating championship on May 18th.
- Softball and Baseball wrapped up season 3.
- Basketball and Wrestling have started their season.

#### Mrs. Blackwell shared the following with the Board:

Congratulations to the boys and girls track teams for their performances last Friday at the District track meet, and yesterday at the State track meet.

At the District meet the girls were led by Laurel Otto who won the 100 meter hurdles, took 3<sup>rd</sup> in the 300 meter hurdles, and 2<sup>nd</sup> in both relays. She qualified for State in all four events as well as the high jump. Athena Lau also qualified for state in four events by taking 2<sup>nd</sup> place in the 15 hundred, the 3000, and the 4 by 400 relay, then qualifying in the 800 based on her previous time.

Other team members of the relays who qualified for state were Tyra LeFeber, Mariah Adams, and Carrie Jones. Carrie also qualified for state in the 400 meters.

At the State meet yesterday Laurel took 3<sup>rd</sup> in the 100 hurdles, and 4<sup>th</sup> in the 300 hurdles, Athena placed 4<sup>th</sup> in the 3000 and 8<sup>th</sup> in the 15 hundred. Carrie placed 9<sup>th</sup> in the 400. Our 4 by 100 relay team of Tyra, Mariah, Laurel, and Carrie placed 10<sup>th</sup>, and our 4 by 400 relay team of Laurel, Athena, Mariah, and Carrie ran a 13 second PR and placed 5<sup>th</sup>!

At the District meet the boys team was led by Kade Mask who placed 2<sup>nd</sup> in the 400, and 3<sup>rd</sup> in the 300 meter hurdles. He qualified for the state meet in both of these events and finished 7<sup>th</sup> in the hurdles and 8<sup>th</sup> in the 400. Jace Martinelli finished 4<sup>th</sup> at district in the high jump which also qualified him for the state meet. Other top placers at the district meet were the 4 by 400 relay who placed 3<sup>rd</sup> with Kade Mask, Ray Bennett, Levi Forson, and Jacob DeWilde. Teague Mendez also took a 3<sup>rd</sup> place in the pole vault.

Both boys and girls teams placed 4<sup>th</sup> overall at the district meet. The girl's team then placed 12<sup>th</sup> at state meet and the boys placed 24<sup>th</sup>.

Mr. Martinelli wanted to let the Board know that we did receive a summer school grant for the high school. We have a couple of staff that will be teaching summer school for the students that need the credit recovery.

Mr. Martinelli want to let the Board know that Walgreens are offering COVID vaccines clinics at local schools for the community. Want to know if this is something that you are interested in? Linn Country has made it clear that any child under the age of 18 has to have parent consent to receive the vaccine. This is free to the school district. They provide all the staffing, we just have to provide a place. Mr. Martinelli will reach out for more information and get back to the board. Kerri Hyde commented on that SMTA is holding a vaccine clinic.
