Safe Return to In-Person Instruction and Continuity of Services Plan

In order to best supportstudents and families with the safest possible return to school for the 2021 school year, the Oregon Department of Education (ODE) has created an operational plan template to align guidance from the federal and state level in support of local decision-making and transparency of health and safety measures in the communities that school districts serve. The Safe Return to In-Person Instruction and Continuity of Services Plan serves the following purposes:

- 1) Replaces the Ready Schools, Safe Learners Operational Blueprint required under Executive Order 21-06; and
- 2) Meets the requirements for:
 - a. An operational plan required under OAR 581-022-0106[4] while aligning the CDC Guidance on School Reopening with the Ready Schools, Safe Learners Resiliency Framework for the 2021-22 School Year (RSSL Resiliency Framework);
 - b. Section 2001(i)(1) of the ARP ESSER and the US Department of Education's Interim Final Requirements for Safe Return/Continuity of Services Plan; and
 - c. Communicable Disease Plan and Isolation Plan under OAR 581-022-2220 (Division 22 requirements).

As districts plan and implement the recommendations in ODE's RSSL Resiliency Framework, they will need to consider a continuum of risk levels when all recommendations cannot be fully implemented. For example, universal correct wearing of face coverings between people is one of the most effective preventive measures. However, there will be times when this is not possible based on a specific interaction or a physical space limitation, such as during meal times. It will be necessary to consider and balance the mitigation strategies described to best protect health and safety while ensuring full time in person learning.

ODE remains committed to the guiding principles introduced in spring of 2020 to generate collective action and leadership for efforts to respond to COVID-19 across Oregon. These principles are updated to reflect the current context:

- Ensure safety and wellness. Prioritizing basic needs such as food, shelter, wellness, supportive relationships and support for mental, social, and emotional health of students and staff.
- Center health and well-being. Acknowledging the health and mental health impacts of this past year, commit to creating learning
 opportunities that foster creative expression, make space for reflection and connection, and center on the needs of the whole child
 rather than solely emphasizing academic achievement.

- Cultivate connection and relationship. Reconnecting with one another after a year of separation can occur through quality learning
 experiences and deep interpersonal relationships among families, students and staff.
- Prioritize equity. Recognize the disproportionateimpact of COVID-19 on Black, American Indian/Alaska Native, and Latino/a/s. Pacific
 Islander communities; students experiencing disabilities; students living in rural areas; and students and families navigating poverty and
 houselessness. Apply an equity-informed, anti-racist, and anti-oppressive lens to promote culturally sustaining and revitalizing
 educational systems that supportevery child.
- Innovate. Returning to school is an opportunity to improve teaching and learning by iterating on new instructional strategies, rethinking learning environments, and investing in creative approaches to address unfinished learning.

3.7 Centennial Student Handbook Changes:

Centennial 2022-2023 Handbook Changes

- 1. Dates, staff assignments and names were updated.
- 2. Quarters were switched to trimesters.
- 3. The dress code was re-written with parent and staff input to more closely reflect the high school dress code.

Here is a copy of the old handbook's dress code:

Dress Code

The following is designed to allow for comfort, avoid distractions, and promote self-respect. When the dress code has been violated, parents will be contacted. Alternative clothing will be provided when available and/or may be brought from home.

- Clothes may not distract from the learning process.
- Students may not wear clothing that supports or glamorizes alcohol, tobacco, drugs, gangs, or violence, or that has sexual or derogatory messages, including writing on the seat of pants.
- Clothes may not expose the torso or undergarments. They may not be torn, ripped, or cut in an immodest fashion.

- Tank tops must have at least one (1) inch straps and be snug fitting around the arms. No spaghetti straps unless covered by another top.
- Shorts, dresses, and skirts will be longer than the student's fingertips hanging by the side. If skirts or dresses are shorter than the knee, then shorts or leggings must be worn underneath.
- Hats and/or hoods are to be worn outside only. Hats and/or hoods may be worn inside on special occasions such as spirit days, or with the teacher's permission.
- Hoods may not cover the students face and should be taken off when entering a building.
- Shoes with wheels may only be worn to school if the wheels are removed.
- Makeup is not encouraged during the elementary school years.
- Students should wear flat, toe-covering shoes on PE days. No heels, flip-flops, or boots, please.

3.8 High School Graduation Requirement Change:

Scio High School Mentor/Mentee Shift

Shifting from Four Years of Mentor/Mentee to 9th-grade Freshman Success & 11th Grade Careers class.

Why the change? - Many students, parents, and staff feel 4 years is difficult to do keeping students motivated. Often time we hear - "I don't have to do that now; I will just do it next year". The concept was great to meet the Career Related Learning Standards (CRLS) and a place to capture every student completing their Extended application. Students are required to get a 0.5 credit for Career education and that will stay in place. We are taking the 4 years and condensing it to 2 years.

Proposed Change:

Freshman Success Class (all Freshmen will be required to take a 1-trimester class). 0.5 Elective Credit

Junior Careers Class - All Juniors 1 trimester 0.5 Career education credit

This course will include:

- Resume', Cover letter, and Application processes (building, editing, practicing)
- Exploration of careers & colleges
- Career Fair
- Job shadow
- Extended application (essay & presentation)
- · Community Service
- Career and academic goals
- Evaluation and reflection

Superintendent's Report: Superintendent, Steve Martinelli's packet included:

CURRENT

OHA and ODE have given back local control over many of the health and safety protocols to our district again. Many of these changes occurred on March 11, 2022, at 11:59pm. At our February Board of Directors meeting the Board approved moving to optional masking as soon as it was legal for our district to do so. Below are the new protocols we will adhere to moving forward as long as we are still given local control over the health and safety protocols.

- Masking will be optional for all staff and students in all buildings and on school buses.
- Quarantine rules will be put on pause (students and staff who have been exposed to a known case of COVID-19 will be informed of their potential exposure but will not be subject to mandatory quarantine).
- Isolation for confirmed cases of COVID-19 will continue (any confirmed cases of COVID-19 will be required to isolate for a minimum of 5 days at home, and at least 24 hours fever free without using medication, and can return on day 6. It will be recommended that they wear a mask for days 6-10 upon their return to school).
- Physical distancing will continue to be considered when it does not negatively impact instruction or learning activities.
- Cohorting will be considered where it makes logical sense and does not negatively impact instruction or learning activities.
- Hand washing and respiratory etiquette will continue to be emphasized and reinforced with all students and staff.
- Free on-site COVID-19 diagnostic testing will continue to be conducted at each school site. Any and all testing for students ages 17 and under will require parent permission, including a signature on the permission to test form.
- We will continue to communicate with Linn County Public Health if we see a rise in cases which increase the absences of our students.
- The mandatory vaccination mandate is still in effect. All staff and volunteers who do not meet the
 definition of fully vaccinated will still need to complete weekly testing. This testing can be completed at
 any school site on Tuesdays. More information will be coming out regarding these requirements.
 Optional masking is for all staff, students, and volunteers.

Mr. Tempel presented to Board information about the COP Grant. This is a matching grant so If we do this Scio School District would need to come up with 25%.
