4.1 Superintendent's Report: Superintendent, Steve Martinelli's packet included:

CURRENT

1. Middle School Principal Selection

- 1. June 29, 2022: We completed first round interviews for our Middle School Principal Position. Three finalists were chosen for a 2nd round of interviews.
- 2. July 7, 2022: 2nd round of interviews scheduled.
- 3. July 1, 2022: We were informed that our high school principal accepted a position in another district. The decision was made to halt the middle school principal selection process and open the high school principal position, allowing candidates to apply for both
- 4. July 7, 2022: Finalists meet and greet with the Board of Directors
- 5. July 11-12, 2022: Interviews for the High School Principal position were completed.
- 6. July 12, 2022: After 18 hours of interviews, 20+ hours of reference calling, 16 pages of pros and cons listed, several times of changing my mind, and several sleepless nights we have offered the two positions to two of our and they both accepted.
- 7. Kyle Braa will be our new High School Principal and Jacob Alburn will be our new Middle School Principal.

2. Seismic Grant

a. The seismic project at the Scio Middle School is moving along quickly. The middle school building will continue to be unavailable for the majority of the summer, but we will be very happy with the upgrades when the project is complete.

3. Scio School District Strategic Planning

- a. 2022-23 we will begin another round of school improvement planning
- b. Community input will be required and sought after to help us with determining our student's and school's greatest needs.
- c. Both of our new administrators will be working to get to know their staff, students, and community over the next few months. This will be a great way to gather much needed information and feedback for our improvement efforts.
